## ADMINISTRATIVE FEES

Type	Service Provided	Fee
At the discretion of the City Manager or his designee, reproduction, copying, transcribing or similar services may be outsourced to a private vendor. In all such cases, the requestor shall be responsible for payment of all charges as assessed by the private vendor. Decisions to outsource work shall be based upon operational considerations, including the desire to ensure that regular City functions and operations are not adversely affected by large requests or a large number of requests in a short time frame. (Actual cost(s), including shipping and handling, as charged by private vendor.)
