#### 5. PUBLIC HEARINGS

## **a.** SR 167 Annexation

Associate Planner Brianna Burroughs gave a presentation on the 167 annexation. The presentation acted as a precursor to the following public hearing.

Senior Planner Chris Larson commented on the Urban Growth area maps, and that Milton and Fife have separate UGM's. Steve Friddle also offered additional information regarding the annexation and the plan of annexation.

The Public Hearing was opened at 7:20pm.

## Speaker: Naomi Lamoureux 1428 69th Ave E

Ms. Lamoureux inquired about how the properties on the hill will be affected by SR 167 (property value and noise). Community Development Director Steve Friddle responded that the property is part of unincorporated Pierce County. He also stated that while the property is not currently part of the annexation, it may be up for consideration in the future. Director Friddle concluded that the Washington State Department of Transportation will be holding public meetings to discuss effects on population/noise/etc.

#### Speaker: Pete Lewis, Contractor city of Milton

Mr. Lewis stated that he had previously met with Senior Planner Larson and agreed that there needs to be future discussions on the areas that the Growth Management Act labels as common area to both cities.

The Public Hearing was closed at 7:32pm.

Commissioner Braden moved and Commissioner Waldner seconded a motion to recommend the proposed 167 Annexation for approval by the Fife City Council.

## Motion carried unanimously.

## 6. ITEMS OF BUSINESS

**a.** Sundsmo Rezone CPA 16-0001 48<sup>th</sup> St. Comp Plan and Rezone Senior Planner Chris Larson gave a presentation on the Sundsmo rezone. He gave updates to the potential rezone as well as responded to questions that were asked at the June 6, 2016 Planning Commission meeting.

Commissioner Waldner motioned, and Commissioner Braden seconded a recommendation: "to approve the privately initiated Comprehensive Plan Amendment CPA16-0001 and Rezone REZ16-0001, and to add the five (5) cityowned properties, changing the Land Use Designation from Low Density Single Family Residential to Mixed Medium Density Residential/Commercial and the zoning from Single Family Residential to Medium Density Residential."

## **Motion Carried Unanimously**

**b.** 2016 Comprehensive Plan and Capital Facilities Plan Updates Community Development Director, Steve Friddle, gave a brief overview of the Comprehensive Plan and Capital Facilities Plan updates.

Commissioner Wood motioned, and Commissioner Waldner seconded "to recommend that the Fife City Council approve proposed amendments as contained in the April 4, 2016 staff reports".
