COUNCIL DELEGATE REPORT

ORDINANCES AND RESOLUTIONS ORDINANCES: #1739 International Building Code Update (Durham)

#1739 International Building Code Update

David DeGroot, Finance Director, read the title of Ordinance #1739

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON, AMENDING SECTION 15.04.903 OF THE FIFE MUNICIPLE CODE REGARDING AUTOMATIC SPRINKLER SYSTEMS

Community Development Director, Carl Durham pointed out that the City of Fife needs to address an omission in fire code and amend the fire sprinkler requirements for buildings regulated by the International Building Code (IBC). These sections mandate the installation of fire sprinkler systems when fire areas exceed 6,000 square feet, except for Hazardous and Institutional occupancies. The omission affects Business occupancies and research has shown that the omission occurred since 2004 and the reason for the omission is unclear. We also need to include all fire areas for Factory Occupancies. All businesses are currently up to code, so this will remain the standard for all new businesses.

The Ordinance will be placed on the Consent Agenda for the next Council meeting.

Kurt Reuter, Parks & Recreation Director presented history and an update on the status of the Caboose restoration project. Dave Zabell, City Manager, opened with comments about the state of the Caboose Project.

David Cantlin, Parks and Recreation Maintenance Operations Manager, also spoke about the restoration project.

Councilmember's addressed their concerns and opinions on the Caboose.

Rick Bacon with the Tacoma Chapter National Railway Historical Society spoke about an upcoming convention and some grants that we could apply for. He also spoke about what he felt was needed to finish the Caboose Project.

Ray Richards, a former volunteer on the Caboose restoration project, shared history of the Caboose restoration. He addressed the need for good leadership and planning in order to complete the project.

Louise Hospenthal, Fife Historical Society President, addressed Council and voiced their desire to have the caboose near the museum.

Mike Kelley, previous Fife City Councilmember and Mayor, made suggestions for the use of the caboose.

Discussion of WSDOT 20th Street Closure for I-5 work (Blount)

Discussion of WSDOT 20th Street Closure for I-5 work

20th Street Drive East Closure for WSDOT Construction of a new Northbound I-5 Bridge over the Puyallup River.

Russ Blount, Public Works Director presented to Council for consideration the conditions to be imposed on Washington State Department of Transportation (WSDOT) in return for vacation of a portion of 20th Street Drive East right-of-way, vacation of property rights to the Native Growth Protection Easement obtained from Praxair in 2008, and allowing a 2-year closure of 20th Street Drive East. This would be for construction of a new Northbound I-5 Bridge over the Puyallup River.

Councilmember's discussed their concerns about 20th Street Closure, and the need to keep the business community informed.

Lodging Tax Restoration (Zabell)

During the Fife City Council Retreat in January, Council expressed their desire to reimburse other funding sources that were used in lieu of monies from the Stadium/Convention Fund, pending the sale of the Gathering Place property.

FISCAL IMPACT:

\$102,000 from the Stadium/Convention Fund to be allocated to:

General Fund: \$5,000-City Marketing Program

General Fund/Council Project: \$7,000-Fife Float, \$25,000-Festival, \$30,000-Museum

Growth Mgmt/REET: \$20,000-Museum Water Utility: \$5,000-City Marketing Program Sewer Utility: \$5,000-City Marketing Program Storm Drainage: \$5,000-City Marketing Program

Councilmember Hull abstained, all other Councilmembers agreed on the restoration.

CITY MANAGER REPORT

Fife City Manager, Dave Zabell, discussed the approval of the 47th Avenue sidewalk grant and the ADA upgrades to City Hall. He also updated Fife City Council on the current photo enforcement bills and mentioned the early action savings bill, and how it saved \$60,000 for the City of Fife.

CITIZEN COMMENTS

Carol Sue Braaten, resident, commented on her concerns of the new WSDOT ramp meter on the Port of Tacoma Road, and the effects on the evacuation route during the 20th Street closure.
