ORDINANCE NO. 1795

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON AMENDING SECTION 2.52.310 AND REPEALING SECTION 2.52.370 OF THE FIFE MUNICIPAL CODE TO REMOVE UNNECESSARY REQUIREMENTS FROM FIFE POLICE DEPARTMENT PROCESSES

WHEREAS, it is appropriate for the City to review its ordinances from time to time; and

WHEREAS, Section 2.52.310 specifies the general minimum requirements for Fife Police Department applicants; and

WHEREAS, Section 2.52.310 contains a problematically vague requirement that the applicant's weight must be proportionate to his or her height; and

WHEREAS, the application process already entails physical fitness tests, rendering the vague initial requirement contained in 2.52.310 unnecessary; and

WHEREAS, Section 2.52.370 contains a series of "tiebreakers" to determine the order of names on the Fife Police Department eligibility list; and

WHEREAS, the currently conditions set forth in Section 2.52.370 can conclude in a tied final result; and

WHEREAS, the conditions for determining the order of names is more appropriately left to the purview of the Civil Service Commission; now, therefore,

THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON DO ORDAIN AS FOLLOWS:

Section 1. Section 2.52.310 of the Fife Municipal Code is hereby amended to read as follows:

2.52.310 Applications – General minimum requirements.

No individual shall be eligible to apply prior to attaining the age of 21. All applicants shall be citizens of the United States and able to read and write the English language. Minimum educational requirements shall be high school graduation or equivalent

certificate. Exceptions to these requirements may be made with the unanimous consent of the commission members.


Section 2. Section 2.52.370 of the Fife Municipal Code is hereby repealed.

Section 3. Each and every provision of this Ordinance shall be deemed severable. In the event that any portion of this Ordinance is determined by final order of a court of competent jurisdiction to be void or unenforceable, such determination shall not affect the validity of the remaining provisions thereof, provided the intent of this Ordinance can still be furthered without the invalid provision.

Section 4. This Ordinance shall be in full force and effect five (5) days after publication as required by law. A summary of this Ordinance may be published in lieu of the entire Ordinance, as authorized by State law.


