ORDINANCE NO. 1807

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON, AMENDING SECTION 9.08.040 OF THE FIFE MUNICIPAL CODE TO REMOVE UNACCEPTABLE LANGUAGE AND MORE NARROWLY TAILOR THE PARAMETERS OF THE CRIME OF LOITERING

WHEREAS, the current Fife Municipal Code section regarding loitering on school grounds is too broad; and

WHEREAS, the United States Supreme Court has held that a person needs no lawful purpose to loiter in a public place; and

WHEREAS, it is necessary to more narrowly tailor Section 9.08.040 to remain legally enforceable;

WHEREAS, the City of Fife has a vested interest in keeping schools safe places; now, therefore,

THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON DO ORDAIN AS FOLLOWS:

Section 1. Section 9.08.040 of the Fife Municipal Code is hereby amended to read as follows: relationship involving custody of or responsibility for a pupil

9.08.040 Loitering on school grounds.


Any person, except a person enrolled as a student in, or parents or guardians of or persons in a relationship involving custody of or responsibility for such student, or person employed by the school or institution, who willfully loiters about the building or buildings of any public or private school or institution, including schools or institutions of higher learning, or the public premises thereto without any license or privilege to be there, shall be guilty of a misdemeanor.

Section 2. Each and every provision of this Ordinance shall be deemed severable. In the event that any portion of this Ordinance is determined by final order of a court of competent jurisdiction to be void or unenforceable, such determination shall not affect the validity of the remaining provisions thereof, provided the intent of this Ordinance can still be furthered without the invalid provision.


