ORDINANCE NO. 1823

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON AMENDING SECTION 6.01.050(A) OF THE FIFE MUNICIPAL CODE TO CORRECT A SCRIVENER'S ERROR

WHEREAS, it is appropriate for the City to review its ordinances from time to time and to amend them to correct errors; and

WHEREAS, a Scrivener's error has been found in the Fife Municipal Code Section 6.01.050(A) where the word "potentially" is used by mistake;

WHEREAS, the City desires its code to be as accurate and clear as possible; and

WHEREAS, this ordinance is a housekeeping ordinance that corrects this incident;

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON DO ORDAIN AS FOLLOWS:

Section 1. Section 6.01.050(A) of Fife Municipal Code is hereby amended as follows:

6.01.050 Registration, permits and fees for dangerous animals.

A. Following the declaration of a dangerous animal and the exhaustion of the appeal therefrom, the owner of a dangerous animal shall obtain a permit for such animal from the animal control authority, and shall be required to pay the fee for such permit in the amount of \$500.00 to the city or the city's designee. In addition, the owner of a dangerous animal shall pay an annual renewal fee for such permit in the amount of \$500.00 to the city or the city's designee.

Section 2. Each and every provision of this Ordinance shall be deemed severable. In the event that any portion of this Ordinance is determined by final order of a court of competent jurisdiction to be void or unenforceable, such determination shall not affect the validity of the remaining provisions thereof, provided the intent of this Ordinance can still be furthered without the invalid provision.

Section 3. This Ordinance shall be in full force and effect five (5) days after publication as required by law. A summary of this Ordinance may be published in lieu of the entire Ordinance, as authorized by State law.


