
A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON AUTHORIZING EXECUTION OF AN AMENDMENT TO THE AGREEMENT WITH THE CITY OF MILTON FOR POLICE DISPATCH SERVICES

WHEREAS, On November 14, 2006, Fife and Milton entered into an agreement titled "2006 Interlocal Agreement for Dispatch Services City of Fife/City of Milton" (the "Agreement"), which continues to be in full force and effect; and

WHEREAS, in consideration of Milton contemporaneously executing a jail services agreement with Fife, the parties desire to amend Section 5 of the Agreement regarding price of services for the years 2013 and beyond; now, therefore

BE IT RESOLVED, that the Fife City Council hereby authorizes the City Manager to execute the First Amendment to 2006 Interlocal Agreement for Dispatch Services City of Fife/City of Milton in the form attached hereto as Exhibit A.



FIRST AMENDMENT TO  
2006 INTERLOCAL AGREEMENT FOR DISPATCH SERVICES  
CITY OF FIFE/CITY OF MILTON

1. Dated and Parties. This document ("First Amendment"), for reference purposes only, is dated the \_\_\_ day of October, 2012, and is entered into between the City of Fife ("Fife") and the City of Milton ("Milton").

2. Background and Purpose.

a. On November 14, 2006, Fife and Milton entered into an agreement titled "2006 Interlocal Agreement for Dispatch Services City of Fife/City of Milton" (the "Agreement"), which continues to be in full force and effect.

b. In consideration of Milton contemporaneously executing a jail services agreement with Fife, the parties desire to amend Section 5 of the Agreement regarding price of services for the years 2013 and beyond.

3. Amendment to Agreement Section 5. Section 5 of the Agreement is hereby amended to read as follows:

5. Price. Milton shall pay to Fife the following sums:

a. January 1, 2007 – December 31, 2007, \$121,014.15

b. Milton agrees to increase the amount paid to Fife each year from 2008 through 2012 by 3.5% or by the CPI of the greater King/Pierce County area, whichever is greater.

c. January 1, 2013 – December 31, 2013, \$115,000.00

d. January 1, 2014 – December 31, 2014, \$115,000.00 plus the percentage increase in the Seattle CPI-W from July 2012 to July 2013, not to exceed 3%.

e. The price for each subsequent year shall be increased from the previous year's price by the percentage increase in the Seattle July-July CPI-W.

4. Confirmation of Agreement Terms. The First Amendment terms are deemed modifications to the Agreement terms, and, except as modified herein the Agreement shall remain in full force and effect and its terms are incorporated herein. In case of a conflict between the terms of the Agreement and this First Amendment, the terms of the First Amendment shall control.

5. Authority. The Milton City Council has authorized the execution of this First Amendment by official action taken the \_\_\_\_ day of \_\_\_\_\_, 2012.
