

RESOLUTION NO. 1521

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON APPOINTING CERTAIN INDIVIDUALS TO THE LODGING TAX ADVISORY COMMITTEE, THE FIFE PUBLIC ARTS COMMISSION, THE PLANNING COMMISSION, THE PARKS RECREATION AND COMMUNITY SERVICES CITIZEN ADVISORY BOARD, AND THE TREE COMMISSION.


