A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON AUTHORIZING THE CITY MANAGER TO EXECUTE A SECOND ADDENDUM TO THE INTERLOCAL AGREEMENT WITH THE CITY OF EDGEWOOD FOR IT SERVICES


WHEREAS, The City of Edgewood ("Edgewood") and the City of Fife ("Fife") entered into an interlocal agreement dated November 12, 2012 ("ILA"), primarily in order to enable Fife's Information Technology (IT) personnel to provide IT support to Edgewood; and

WHEREAS, the parties executed a First Addendum to the ILA on February 11, 2014, extending the ILA through 2014; and

WHEREAS, Edgewood and Fife mutually desire to execute a Second Addendum to the ILA to extend the term of the ILA through December 31, 2015, and provide a 2.2% cost of living adjustment to the compensation; now, therefore

BE IT RESOLVED that the City Council hereby authorizes the City Manager to execute the Second Addendum to the Interlocal Agreement between the City of Edgewood and the City of Fife Regarding IT Support Services in the form attached hereto.

**SECOND ADDENDUM TO
INTERLOCAL AGREEMENT BETWEEN
THE CITY OF EDGEWOOD AND THE CITY OF
FIFE REGARDING IT SUPPORT SERVICES**

This Second Addendum, dated this _____ day of February, 2014, amends the Interlocal Agreement between the City of Edgewood and the City of Fife Regarding IT Support Services dated November 12, 2012 and amended February 11, 2014 (“the Agreement”).

I. Recitals.

A. The City of Edgewood (“Edgewood”) and the City of Fife (“Fife”) entered the Agreement primarily in order to enable Fife’s Information Technology (IT) personnel to provide IT support to Edgewood.

B. Edgewood and Fife mutually desire to execute this Second Addendum to the Agreement to extend the term of the Agreement through December 31, 2015, and provide a 2.2% cost of living adjustment to the compensation.

II. Terms.

A. Adjustment to Compensation. Pursuant to Section 5.2 of the Agreement, for the 2015 calendar year the regular hourly rate shall be \$51.10 per hour, the after-hours rate shall be \$76.65 per hour, the minimum annual fee shall be \$12,264 (not including authorized work outside of normal business hours), and the maximal annual fee shall be \$17,374 (not including authorized work outside normal business hours).

B. Term Extension. Pursuant to Section 4.3 of the Agreement, the term of the Agreement is hereby extended through December 31, 2015.

C. Effect of Addendum. This Second Addendum modifies the Agreement. Except as amended herein, all other terms and conditions of the Agreement remain in full force and effect.
