

RESOLUTION NO. 1648

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON AUTHORIZING THE CITY MANAGER TO EXECUTE AN ADDENDUM TO THE INTERLOCAL AGREEMENT WITH THE PIERCE COUNTY FOR ANIMAL CONTROL SERVICES AND NAMING MARK MEARS AS THE CITY'S REPRESENTATIVE TO THE PIERCE COUNTY ANIMAL SERVICES ADVISORY PANEL

WHEREAS, on August 12, 2014, the council adopted Resolution No. 1612 authorizing the city manager to negotiate and execute a contract with Pierce County for animal control and pet licensing services within the city; and

WHEREAS, the parties desire to add an addendum to the contract requiring notice to the City of any proposed changes to the County's animal control ordinance, and the opportunity to terminate the contract if the change is material and the City does not agree to adopt the change into the Fife Municipal Code; and

WHEREAS, Pierce County has an Animal Services Advisory Panel that assists the Auditor with animal control policy and customer service, and the County Auditor has requested that a contract city representative be added to the panel; now, therefore

BE IT RESOLVED that the City Council hereby authorizes the City Manager to execute the Addendum to the Interlocal Agreement between the City of Fife and Pierce County Relating to the Provision of Animal Control Services Regarding in the form attached hereto as Exhibit A.

BE IT FURTHER RESOLVED that the City Council hereby names Police Chief Mark Mears as the City's representative on the Pierce County Animal Services Advisory Panel.

Addendum to Animal Services Interlocal Agreement

THIS Addendum (“Addendum”) is made and entered into on the _____ day of _____, 2015, by and between the City of Fife, a Washington municipal corporation (“City”) and Pierce County, a political subdivision of the State of Washington (“County”) (collectively referred to herein as the “parties.”)

The parties agree that the Interlocal Agreement between the City of Fife and Pierce County Relating to the Provision of Animal Services, dated _____, (the “Agreement”) shall be amended by the addition of the following provision:

County shall give the City written notice of any proposed amendments to Pierce County Code Title 6, Chapter 5.24, or Chapter 5.25. If the amendment is a substantive change, and the Parties cannot reach agreement on a corresponding amendment to the Fife Municipal Code, then either party may terminate the Agreement by providing the other party three-month notice to terminate the Agreement.
