

RESOLUTION NO. 1841

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON AUTHORIZING AN AMENDMENT TO THE INTERLOCAL AGREEMENT WITH CITY OF EDGEWOOD FOR SEWER SERVICE

WHEREAS, the City of Fife provides sewer service to a portion of the City of Edgewood in accordance with the terms of the “Interlocal Agreement between the City of Fife and the City of Edgewood regarding Sanitary Sewer Service” (“ILA”) dated November 5, 2013; and

WHEREAS, the ILA includes a map defining the area to be served by the City of Fife, and the north boundary of that area is Yuma Street in Milton, which is known as 20th Street East in Fife and Edgewood; and

WHEREAS, there is a single family residence on Tax Parcel No. 0420085001 at 8518 20th Street (the “Property”) in the City of Edgewood and the Fife sewer service territory, that is currently served by a failing septic system; and

WHEREAS, City of Fife does not currently have a sewer main near the Property to serve the residence, and due to the topography and the parcel’s location at the northeast corner of the ILA service area, it is unlikely that the City will have a sewer main within 300 feet of the Property in the foreseeable future; and

WHEREAS, there is an existing sewer line in 20th Street East owned by Pierce County and providing sewer service to properties in Milton north of the street; and

WHEREAS, the residence at 8518 is located near 20th Street such that wastewater from the residence would flow by gravity north towards 20th Street East; and

WHEREAS, the owners of the Property have requested that they be allowed to connect to the Pierce County line, and Pierce County has expressed willingness to provide sewer service to the house if approved by the City of Fife; and

WHEREAS, in order for the residence at 8518 20th Street East to be served by Pierce County, the ILA must be amended to remove Tax Parcel No. 0420085001 from the City of Fife’s Service Area; now therefore,

BE IT RESOLVED as follows:


1. The above recitals are hereby incorporated as the City Council’s findings and conclusions.

2. City Staff is directed to write a letter of no objection to Pierce County and the City of Edgewood with respect to the connection of the existing house at 8518 20th Street East to the Pierce County sewer, and removal of Tax Parcel No. 0420085001 from City of Fife's sewer service territory.

3. City Staff is further directed to pursue a formal revision to the ILA with the City of Edgewood, to remove Tax Parcel No. 0420085001 from Fife's service area under the ILA, and to revise the Fife Comprehensive Sewer Plan at such time as such revisions can be combined with other required revisions at minimal additional cost.

4. Upon concurrence by Pierce County and City of Edgewood to service by Pierce County and removal from Fife service under the ILA as described in Section 3 above, the City Manager is hereby authorized to execute an amendment to the ILA to effectuate such removal without further council approval.
