SUBJECT: Ordinance No.1694 to amend the school impact fee amounts in FMC 20.15.010.

REPORT IN BRIEF: This ordinance will revise the City's adopted school impact fees, which are codified in FMC 20.15.010. Refer to Item 8b for details.

BACKGROUND: Impact fees are one-time assessments charged to the developer of a residential project to pay for development-generated impacts on public facilities and services.

The table below illustrates the City's current and proposed school impact fee schedule.

Unit Type	Current Rate	Proposed Rate
Single Family	\$3,588.00	\$4,709.00
Multifamily	\$2,001.00	\$2,899.00

DISCUSSION: A public hearing occurred on January 27, 2009 with no public comment.

School District representatives have been notified of City Council meetings where school impact fees are to be discussed.

FISCAL IMPACT: School impact fees are collected at the time of building permit application. The proposed fees, if approved, could result in the reflection of those fees in the final selling price of the residences.


ALTERNATIVE COURSES OF ACTION:

ORDINANCE NO. 1694

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON, AMENDING THE SCHOOL IMPACT FEE AMOUNT AND AMENDING FIFE MUNICIPAL CODE SECTION 20.15.010

WHEREAS, RCW 82.02.050 requires that adequate public facilities as defined by RCW 82.02.090(7) are available to serve new growth and development; and

WHEREAS, consistent with the requirements of Ch. 36.70A, the Growth Management Act (GMA) and pursuant to Title 20 FMC, the City of Fife requires that new growth and development pay a proportionate share of the cost of new facilities and system improvements needed to serve new growth and development; and

WHEREAS, RCW 82.02.050 - .090 authorizes the City to impose school impact fees on new growth and development; and

WHEREAS, FMC 20.15 requires payment of school impact fees prior to issuance of permits for new residential development; and

WHEREAS, on November 25, 2008, following public hearings held on October 28, 2008, and November 12, 2008, the City Council adopted Ordinance No. 1684 which adopted by reference the Fife School District No. 417 and Puyallup School District No. 3 Capital Facilities Plan Updates as part of the 2008 City of Fife Comprehensive Plan Amendments; and

WHEREAS, both Fife and Puyallup School Districts' Capital Facilities Plan Updates, adopted by reference into the City of Fife Comprehensive Plan, contain the data and formula utilized by each school district for calculating the financial impact of each new residential unit on each School District; and

WHEREAS, Fife Municipal Code Section 20.15.010 currently sets the School Impact Fee rate based upon the 2005 City of Fife Capital Facilities Plan; and

WHEREAS, each School District's 2007 Capital Facilities Plan Update indicates that the financial impact upon each School District has changed as the result of new residential development; and

WHEREAS, on January 27, 2009, the City Council held a public hearing in the proposed school impact fee amendments; and

WHEREAS, considering each School District's 2008 Capital Facilities Plan Update, the City Council has determined that school impact fees shall be increased to \$4,709 for single family residential units and increased to \$2,899 for multi-family residential units.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF FIFE, PIERCE COUNTY, WASHINGTON DO ORDAIN AS FOLLOWS:

Section 1. Section 20.15.010 of the Fife Municipal Code is hereby amended to read as follows:

20.15.010 Imposed

There is hereby imposed a school impact fee for residences within either the Fife School District No. 417 or the Puyallup School District No. 3, in the amount of \$4,709 for each single-family residential unit and \$2,899 for each multi-family residential unit. The timing for payment of the school impact fees shall be in accordance with the provisions of FMC 20.10.060.

Section 2. Each and every provision of this Ordinance shall be deemed severable. In the event that any portion of this Ordinance is determined by final order of a court of competent jurisdiction to be void or unenforceable, such determination shall not affect the validity of the remaining provisions thereof, provided the intent of this Ordinance can still be furthered without the invalid provision.

Section 3. This Ordinance shall be in full force and effect five (5) days after publication as required by law. A summary of this Ordinance may be published in lieu of the entire Ordinance, as authorized by State law.



School Districts within the City of Fife





Legend
